In the circumstances reported by the Commissioner of Distilleries and Breweries & Managing Director, A.P. State Beverages Corporation Limited, Vijayawada in the reference cited and after careful consideration of the matter, Government hereby accord permission to M/s. S.P.Y Agro Industries Limited, Udumulapuram, Nandyal, Nandyal District, for export of 75% Annual Production of the Grain based Spirits (ENA/Ethanol/R.S/DS) along with O.B as on 01.04.2024 to Other States/ Countries for the year 2024-25 i.e., for the period from 01.04.2024 to 31.03.2025, subject to the following conditions:

- 1) The Exporter shall produce an indemnity bond on total quantity at the rate of Rs.15.40 per Bulk Liter.
- 2) The Exporter shall pay an amount of Rs.1/- (Rupees One only) per bulk liter towards Export fee.
- 3) The consignment shall not be broken, while in transit and shall be exported in one lot to arrest any misuse /pilferation and to avoid illicit distillation.
- 4) The escort shall be accompanied upto the State border.
- 5) The Exporter shall produce Proof/ Receipt after consignment from the importer within 21 days.
- 6) The permission is liable to be withdrawn, in case of any exigencies.

2. The Commissioner of Distilleries and Breweries & Managing Director, A.P. State Beverages Corporation Limited, Vijayawada shall take necessary further action accordingly in the matter.
